This test is open to all Poodles. Poodle Club of America, Inc. rules will be used. WC/WCX Rules and Guidelines are available from Mrs. Joyce Carelli, PCA WC/WCX Chairman, 220 Amblewood Tr., Hendersonville, NC 28739, jcarelli@bellsouth.net, or are online at poodleclubofamerica.org.

The Test start time will be announced with the running order, after the draw is held. Running order will be sent to each exhibitor by email, will be posted at http://www.centralcarolinapoodleclub.org, and will be posted at the site.

Test Headquarters: Revilo Farm, 3500 Boyd's Creek Hwy, Sevierville, TN 37876 **Birds:** Fresh killed ducks will be used for all tests. Everyone entered in the test or stakes, or working at the test, may take ONE of the birds (1 bird/dog/day) used in the test home. If there are birds left after everyone has one, each person may take additional birds on a first-come first-served basis, as long as everyone who wants them gets an equal share. Birds that were purchased but not used for the test may be purchased at the end of the test on Sunday for \$15.

Prizes: Each qualifying dog will receive a rosette ribbon and duck band. Qualifying WC and WCX Poodles are eligible for Poodle Club of America, Inc. certificates. Each dog or puppy showing interest in birds or retrieving in the Stakes will receive a ribbon.

Bitches in Season and injured dogs: In heat bitches cannot run and must not be out of vehicles until after all dogs have run, and must remain on leash at all times when not in a vehicle. A refund of the entry fee, less bird costs, will be available for bitches in season. A similar refund for injured dogs will be given if a veterinarian receipt is provided.

Food: Complimentary morning coffee and light breakfast foods will be available for everyone. Lunch will be available on-site both days for \$7.00/person. If you would like to reserve a lunch, please fill out the lunch form and send it and payment with your entry to: Judy Butler, Test Secretary at the address on the form. Saturday night there will be a pot luck dinner. See page 6 for details.

Guidelines: There is some shade available, but not necessarily near the test location. Please bring your own shade and water. Dogs must be on leash or confined when not running in test. Electronic collars are not permitted.

Please air/exercise your dogs away from the test location and those areas where there is likely to be foot traffic. **PICK UP after your dog**. This is a privately owned farm. We must leave this facility in exceptional condition. *Individuals not cleaning up after their dogs, or themselves, will be asked to leave.* Please park only where directed. Do not drive in planted fields. **Dogs should not be loose except when running the test.**

Full of life and free of spirit, Río always enthusiastically attacked every task. She started her career in the obedience ring and earned her CDX title. We began agility and she quickly earned her MXP and MJP titles with over 38 1st placements. She also excelled at Rally. She earned her RAE title in a very short time and had 8 legs towards her RAE2. In 2006 she was the #2 Poodle in Rally according to Front & Finish accumulating 306 First and Foremost Points. These points are given based on number of dogs defeated in competition. She loved hunt work and quickly earned her Junior Hunter Title. She earned her WC (Working Certificate) and WCX (Working Certificate Excellent) and was awarded her Bronze, Silver and Gold Medallions by the Poodle Club of America. She had earned the titles in agility, obedience, rally and hunt tests prior to her Atrial Septal Defect (ASD) diagnosis, which proved her dogged determination. Regardless how hard we worked, she never relented. After her diagnosis in June of 2006, thanks to the PCA Foundation who offered free ASD screening at the 2006 National Specialty, and cardiologist, Dr Sonya Gordon, of Texas A & M University Veterinary Teaching Hospital, who repaired her defect, Río was able to continue doing the things she loved so much. In 2009 Río began to show signs of stiffness in her rear end. After a complete orthopedic workup at the University of Tennessee Veterinary Teaching Hospital showed nothing, she began chiropractic and acupuncture therapy at UT under the magic touch of Dr Donna Raditic. Thanks to Dr. Donna, Río was able resume the activities she enjoyed and not need drugs. She had made remarkable progress and with regular therapy, showed no signs of the stiffness. Río was actively involved in some sort of pet therapy program her whole life. She was active in the University of Tennessee H.A.B.I.T. program where she worked at Seymour Primary School in the Ruff Read Program and at Wellington Place Assisted Living Facility. She was most recently involved in the specialty commands program at Patricia Neal Rehabilitation Center working with stroke and head trauma patients. Late last year Río began to show signs of slowing down and loss of appetite. After a thorough workup at UT, she was diagnosed with a heart arrhythmia. After starting her on a heart medication her appetite returned. She seemed to have newfound energy and actually seemed years younger, so her sudden loss came as guite a shock to us. Río attacked all she did with enthusiasm and unbridled energy. She loved to train and was eager to please. Watching her work you would swear she was smiling. She never knew a stranger and continued to be a great ambassador for the therapy programs she was involved in until just before her death. Though it betrayed her in the end, Río truly had a heart of gold.
